  - you have read, understood and agree to be always bound by the Continuing Professional Development (“CPD”) guidelines and the continuing obligations pertaining thereto and
  - You will maintain your membership of LIA
  - If you already hold an LIA Designation or are applying for one, please ensure to read our [CPD Guidelines document](#) in conjunction with these Terms and Conditions.
  - If you allow your membership to lapse and/or if you fail to comply with your annual CPD requirements, your Membership status and/or Designation(s) may be removed
    - In the event of losing an LIA designation (e.g. QFA, QFA FLIA, APA, CUA) and/or CPD Member status which meets the Central Bank’s Minimum Competency Code you have the responsibility of reporting this to your employer (although LIA may provide such information to your employer for the purposes of your employer complying with the Central Bank’s Minimum Competency Code). 2. Where membership and or designation certificates have been issued the certificate(s) remain(s) the property of LIA and should your membership lapse, or if you fail to comply with the requirements for the designation, you are required to return the certificate(s) to LIA.
